# I. <u>APPROVAL OF MEETING MINUTES</u>

### II. <u>NEW BUSINESS</u>

An application for a cell tower special use permit modifications included a letter from a lawyer stating that they did not have to go through the normal process because

- State or local government may not deny, and shall approve any request for modification that does not substantially change the dimensions of such tower or base station.
- 2014 Infrastructure Order "substantial change" defined as:
  - O Towers not in the rights-of-way height not more than 10 percent change, antenna array not more than 20 percent from the existing spray or more than the width of the tower structure, or addition of an appurtenance protruding more than six feet from the edge of the structure
  - Changes in height
- The asked for Planning Board application, completed short SEQR form, and Agricultural Data Statement greatly exceed the required information required

The letter was presented to the planning board for discussion.

• Board is aware they cannot deny an application concerning a modification

- Applications have not been sent to the County Planning Board or has a public hearing been asked for
- Conditions given for modifications are done as a reminder to the applicant
- EME report has been added due to new information and/or technology that becomes available
- Board just validating any original stipulations
- Other applicants have not had trouble completing an application and coming before the board for review
- Board assumes that Mrs. Dale-Hall is checking on this
- Would not hurt to have the Town's lawyer review the letter
- Planning Board would like to continue reviewing any modifications

- Both companies came and talked with the board and then sent a quote to Mr. Keeler
- Next step would be to make a recommendation to the Town Board
- Wendall wanted \$16,617.00 in cash with a total of \$36,666.00 for the project
  - o Mr. Reilly would not our lead person to be working with
  - o Was applying for the Ag & Markets farm land protection grant included?
  - o Inventory for the land use map would be done
  - o Does the cost include a survey?
  - Is not familiar with the area however is working with the Town of Shelby on the Hemlock Ridge Solar Project
- LaBella's cost would be \$29,800 for the project
  - o Mrs. Johnston would be our lead person to work with
  - o Time table would be 12 months from start to finish
  - o Has worked/working with nine of the municipalities in the County
  - Survey cost would be included
  - o Applying for the Ag & Markets Farmland protection plan would be \$1,000.00
